

Michigan Boulevard extension, providing for a doubledecker bascule bridge in the place of the present Rush street swing bridge. This will probably draw most of the automobile traffic from the northeast section of the Loop away from the State, Clark and Dearborn bridges, and by means of the two levels, to be provided, will segregate the rapid from the slow moving traffic, especially that heavy trucking originating in the railroad yards in this northeastern vicinity. This trucking will then find a direct and fairly unimpeded route via Kinzie and Canal streets to the west and south. 2nd. Kinzie street double-decker bridge, also segregating the rapid from slow moving traffic and thus encouraging the abovementioned trucking route around the Loop. 3rd. Canal street improvement, removing the humps in Canal street by equalizing the grade. Canal street is also to be doubledecker south of the new Union Depot, with the grade of the upper level equalized with that of the river bridges and connecting viaducts so that this again will further encourage trucking around instead of across the Loop streets. 4th.
